1. The extent to which and how the funds will be used to implement prevention and mitigation strategies that are, to the greatest extent practicable, consistent with the most recent CDC guidance on reopening schools, in order to continuously and safely open and operate schools for in-person learning.

Technology cases will be purchased to allow for safe transportation of 1:1 Chrome books from school to home. This enables the students to receive educational support if students have to follow CDC guidelines for quarantine.

2. How the LEA will use the funds it reserves under section 2001(e)(1) of the ARP Act to address the academic impact of lost instructional time through the implementation of evidence-based interventions, such as summer learning or summer enrichment, extended day, comprehensive after school programs, or extended school year.

Funds will be used to reduce primary classroom size to provide more small group or individual instruction in our Kindergarten class. Instruction will continue through the summer in addition to after school activities to address learning loss and support curriculum content standards.

Additional funds will be used to support programming and professional and technology services to support students and staff.

4. An LSW will be on staff five days a week. This is an increase of two days a week to support students' social , emotional and mental health needs. The program Leader In Me will be used to create a positive culture and learning environment for our students. We will also use a contracted service to provide behavioral support to our students with special needs. Using the surveys from Panaroma will allow the staff the target behaviors and mental health supports.

5.
